#### January 26, 1837 Michigan Becomes a State

The area that is now the state of Michigan had a difficult beginning. It was part of the area that was claimed for France in the later part of the 1600s. It then passed to Britain when the treaty was signed that ended the French and Indian War. After the Revolutionary War, although the territory was to belong to the newly formed United States, the British did not want to leave the Michigan territory and continued to show their influence for another thirteen years. Finally, the British influence ended and Michigan became part of the territories of the United States. Michigan became a state while the United States was trying to negotiate between the free and slave state groups prior to the Civil War. This was a very trying time in the history of the United States. Unfortunately for the country and its citizens, it ended in the Civil War instead of being solved peacefully. The regiment from Michigan was the first western regiment to reach Washington during the war in which 90,000 Michigan soldiers served. Some famous people from Michigan include Edna Ferber, Ben Carson, Larry Page, Charles Lindbergh, and Henry Ford.

Look at the map of Michigan below. Label the capital of Michigan. Locate the cities of Kalamazoo, Detroit, Flint, Grand Rapids, Cadillac, Saginaw, Sault St. Marie, and Mackinaw City and label them on the map. Now label the Menominee Mountains, the Porcupine Mountains, and the Huron Mountains, along with Mount Arvon and Mount Curwood, the two highest mountains in Michigan. Also, locate Ford River, Menominee River, the Straits of Mackinac, Grand River, Lake St. Clair, and the Muskegon River and label them.
